# **TERMS OF USE**

#### **COMPANY's General Information**

The website **www.nickmusic.gr** is an online store, selling products through the Internet, created by the COMPANY "G.P. Cineapolis (Cyprus) LTD", located in Cyprus, at 65 Prodromou Avenue, (here in after referred to as "COMPANY"), INT.VAT CY10160509W, Tel. +357/22/660102, under the terms and conditions set out in this statement. The following terms and conditions will apply to the use of the e-shop under the trademark **nickmusic.gr**, which is available at **www.nickmusic.gr**.

Using this website you accept and consent to the present Privacy Statement as well as to the site 's terms and conditions of use communicated through it.

Any user who enters and uses the e-shop services (here after referred to briefly as a "visitor" and/or "user" or "customer" depending on whether he is limited to visiting the online store only or, also making an order), unreservedly endorses the terms outlined here without any exception.

If any user does not agree with these terms, then he must abstain from visiting and using any transaction or services available through the online shop <a href="www.nickmusic.gr">www.nickmusic.gr</a>.

The customer declares that he expressly and unconditionally accepts the above terms of cooperation and agrees to purchase any products according to them.

The user also states that he guarantees to use the **www.nickmusic.gr** website in accordance with these terms, the applicable rules and provisions of national, community and international law and morality. The user is liable for repairing any damage that may be caused to the COMPANY or any third party, by illicit and/or improper use of the services or pages or of any part of this e-shop, as well as by the introduction, publication and transmission through it of any information , text, software or file. ## Personal Data Security - Transaction Privacy Statement

The present Personal Data Security and Transaction Privacy Statement describes the method these data are collected by the COMPANY, the terms and conditions of their use, that you provide during your visit, registration, or entry to **www.nickmusic.gr**, under any access status (visitor, user, client) and as described below in this statement.

THE COMPANY created the website **www.nickmusic.gr**, with the sole purpose of providing immediate service to its users. The site is simple and user-friendly while it is designed to meet the needs of the user. In order to achieve your best service, it is important to understand that you need to provide us with specific information (e.g. information regarding order processing), which are preserved by us.

User data (name, occupation, e-mail address, home address, etc.) and their transactions at the online store are treated as confidential, as is the case with regular transactions at a merchant shop. Users, when providing their data in their transactions, declare, by accepting this statement, that they consent to and accept the forthcoming processing of such data (personal data) for the needs of a smooth and easy exchange between the parties, as well as the transmission of these data to recipients who will be specifically identified and are the employees and acquirers of the COMPANY in the context of the execution of the drawn up contract.

The existence of the right of access and of the right to object in accordance with articles 12 and 13 of Law L.2472/1997 is also hereby notified. It is ensured that only authorized employees have access to transaction information and only when it is necessary (e.g. for orders processing).

For the rest, the COMPANY undertakes not to disclose the data of visitors, customers, users and their transactions and to distribute absolutely no information concerning them to any other organization /company or third party not associated with it, unless it has written authorization by them, or this is required by a court decision or a decision of another public authority. The personal data declared at the online store, are exclusively used by the store itself for the purpose of supporting, promoting and executing the transaction relationship. All documents and electronic data exchanged between the parties in the context of the sale will be held by the COMPANY. The customer can access them if he so desires.

## User Registration and Login to the website

Anyone can visit and use the online store of the COMPANY without particularly giving his or her personal data unless he wishes to: a) register in our website, b) contact us by e-mail at info@nickmusic.gr, (c) order a product(s) as a registered user.

When registering on the site, the user has the obligation to fully register his/her real personal data. To enter the company's online store as a registered user, he/she must create his/her own account, setting out, among others, two codes: the entrance code (Username) and the security personal code (Password). For safety reasons, we strongly recommend that you change your personal Password at regular intervals and avoid using the same codes. However, you must be aware that by using our services, you are fully responsible for the security of your personal account information. In case of their loss or leakage you must notify us immediately. The COMPANY is not responsible for the malicious use of such data by an unauthorized or third person, or for any leakage of such data after malicious attack on the online store or the hosting provider (server).

The COMPANY reserves the right to delete a user's account in the case of noting that: (a) the data he has stated are untrue, (b) he uses his account abusively, (c) has never made a transaction, (d) seeks to alter the nature of the online store, e) has not been logged in to his/her account in the last 12 months.

## In detail during user's registration:

The www.nickmusic.gr website collects data in the following cases:

- Data provided by the user during his/her registration as a customer and data he/she provides when connecting through another platform (Facebook, Android, IOS, Google, e.t.c applications).
- Data provided by the user when completing the order form on our website, such as name, address, area's ZIP code, email address, telephone number, credit card information, order payment method, etc. Also, more specific information may be additionally requested, such as billing, shipping and delivery information of an order, or further details and information on products of any interest.
- Website www.nickmusic.gr is entitled to make use of these information provided by the user so as to contact him/her for additional information about the delivery of the order in his/her premises, for confirmation and identification in all necessary cases, for new products offered by nickmusic.gr or for special offers. The COMPANY'S online store does not in any way disclose, publish or transfer to third parties your personal data and information you trust us as a registered user. These data are used exclusively for the execution of your transactions, are classified, encrypted, and securely kept.

- \* In the case of payment via Bank Wire Transfer to an account of the COMPANY, it is necessary to send the certificate of transaction from the customer's bank to <a href="mailto:info@nickmusic.gr">info@nickmusic.gr</a>.
- \* The COMPANY is not responsible for any additional charges that may arise between the customer and the bank dealing with, or between the customer and the bank the COMPANY deals with, when purchasing and paying for physical or electronic products and services through Credit Debit Card, Bank wire Transfer, PayPal, or any other form of payment for the transactions described in this statement and concerns the COMPANY's online store.

### **Order Cancellation**

The customer reserves the right to cancel the order until the time of receipt by the courier service for its delivery. The cancellation request can be made either by telephone (00306986096100) during the opening hours of the stores, or by sending the request via e-mail at info@nickmusic.gr, listing your order number and cancellation number. If the order has been executed and shipped, it cannot be canceled.

### **Returns of Products or Money**

The customer reserves the right to return the products he has purchased from the online store <u>only if the</u> <u>product is defective or damaged</u> within three (3) days from the date of receipt. For returns, you must immediately contact the online store, through email or by phone at 00306986096100.

The return of the product to be replaced should be conducted with all the documents accompanying the product (e.g., Receipt, Invoice, etc.) and its full packaging.

If the case is about a defect found later than delivery and packaging does not exist, it is not necessary to package the product. The return of the products will take place either by courier, or at one of the stores that constitute partners of the COMPANY.

In cases of return by courier, the customer is charged with the expenses of shipment to the COMPANY. There is no return of the customer's shipping costs to the COMPANY if the customer has chosen a delivery method different from the courier service that the COMPANY cooperates with.

Upon return of the products, the defective products reported by the customer are checked and then the CONPANY communicates to inform him about the results of the inspection. If a defect is found, the product is replaced directly by the COMPANY with a **similar new one** and **in no case a refund is given**. The COMPANY in this one and only case is obliged to bear all the shipping costs to the customer.

Defective products returned after the specified time limit will not be accepted.

## It is also clarified that:

- 1) The COMPANY **never makes a refund**, whether it concerns products in their natural form (e.g. books) or products in digital electronic form (e.g. PDF, E-books, Video or Audio files, etc.).
- 2) In case of purchase and delivery of digital products via Internet (electronic form such as PDF, E-books, Video or Audio files, etc.), the COMPANY does not accept in any case the cancellation of the order of the above electronic products, nor the refund after the execution and completion of their shipment.
- 3) The COMPANY is fully committed to the **direct refund to the customer**, **exclusively and only**, for any payments on his part regarding unavailable or sold out products. The return of money to the customer will be conducted by the same means as the original payment. In particular:
- A) In the case of debit card payment, the COMPANY will be obliged to inform the issuing Bank about the cancellation of the transaction and the bank will then proceed to any operation provided according to the contract it has drawn up with the customer without any liability of the COMPANY anymore. The COMPANY after this reference shall not be liable for the time and manner of execution of the settlement set forth in this contract.
- B) In the case of payment by **bank wire transfer**, a bank wire transfer will be made in reverse from the COMPANY'S accounts to the client. The same will apply to **PayPal payment** case. Any costs incurred (and only in the case of a refund as described in this declaration) shall be borne by the company.

#### Time of Order Shipment and Products Delivery

When the order is placed, the customer is informed by e-mail to confirm the order. If the products are available the delivery time is 2 to 3 working days. The delivery time of an order may vary depending on the kind of shipment and receipt chosen by the customer as well as the destination. In the case of purchase and delivery of digital products (electronic form such as PDF, E-books, Video or Audio files, etc.) via the Internet, it will be executed directly within the same day.

## **Product Returns due to delivery error**

In all cases in which other products than the ordered ones are delivered, in type or quantity which has previously been stipulated with the COMPANY in writing, the customer should immediately contact the online store through e-mail or by telephone for their return to the COMPANY, checking and verifying the error. In case of an error, the costs of returning the products to the COMPANY, as well as the cost of dispatching the replaced product to the customer, shall be borne by the COMPANY.

The COMPANY fully complies with the provisions of the Civil Code regarding sales as well as the provisions of L.2251/1994 on Consumer Protection as amended and in force.
